The subjects to be discussed or considered or upon which any formal action might be taken are on the Agenda following.

The vote on the ordinance, resolution, or order setting the tax rate must be a record vote and 60% of the governing body must vote in favor of the adoption of the tax rate. A motion to adopt the ordinance, resolution, or order must be made in the following form: I move that the property tax rate be increased by the adoption of a tax rate of 0.004798, which is effectively a 1.54 percent increase in the tax rate.
