Of Note...

As you are aware, I spoke to the Senate Education Committee on behalf of HCDE with respect to Senate Bill 1216 (SB1216) on Tuesday of this week. The hearing, which was broadcast via the following URL-http://tlcsenate.granicus.com/MediaPlayer. php?view_id=5&event_id=1289-was a spirited discussion regarding the recently-filed amendment to SB1216 that calls for a Sunset Review of HCDE. There was brief, yet potent, exchange between the members of the Senate Education Committee. Likely, the most contentious point was the dialogue between Senator Bettencourt and me. As I explained to him and the members of the committee during the hearing, while I am pleased that the bill has been modified and no longer includes language calling for the abolishment of HCDE, I do not believe that HCDE should be placed under a Sunset Review. Unfortunately, the hearing ended abruptly due to legislative timing protocol. We will continue, however, to follow this bill.

The remainder of the week has been hectic and busy as usual. We continue to move forward through the budget process. With the arrival of the month of May, our campuses are readying for close-out of the school year, and our client districts' needs continue to evolve as we close in on the end of another academic session. Today, I had the opportunity to meet with the superintendents from both Stafford MSD and Wharton ISD. I will continue to further cultivate relationships between HCDE and area leaders in public education.

As of this week, the auditors are no longer onsite; however, our staff continues to work with them in fulfilling their requests for additional information as they begin the process of reviewing our data offsite. We anticipate that this process will continue through the month of July, and we expect them to issue a report during the month of August. I will apprise you of any new developments associated with the audit.

HCDE continues to serve as a beacon of light for La Marque ISD. We continue to manage their financial reporting processes, and also supervise their business functions.

Next Thursday, May 7th, I will be the keynote speaker at the local chapter of the Women Professionals in Government luncheon. I look forward to enlightening this group of government professionals on HCDE. This offers yet another platform to further increase our visibility.
