## Educators Strategize on Decreasing Truancy at Attendance Officers Meeting September 10

Attendance officers, school counselors and Child Protective Service officers throughout Harris County came to HCDE to meet about the ramifications of HB 2398 on Sept. 10. Discussions between the 200 attendees included how the law will affect schools, families and the court system. Texas Gov. Greg Abbott signed legislation to decriminalize truancy this summer.



Nathaniel Broussard, Cy-Fair ISD attendance officer, welcomed the group along with Center for Safe and Secure Schools Director Ecomet Burley. An overview of the criminal juvenile justice system was presented by Katie Chancia, staff attorney for Harris County Justice Courts.



Assistant District Attorney Johanna Craft talked about truancy prevention measures and truancy referrals. The event included a question-and-answer session at the end.

## 5 tips from Cyber Education Specialists to Keep Kids Digitally Safe, Create Responsible Online Citizens:

When it comes to student safety in the cyber world, digital content and education specialists David McGeary and Lynnice Hockaday know about the threats. From predators to hackers to intellectual property theft, they hear many a story in the trenches.

### Conflict of Interest Forms Released to the Public

Due to recent changes to Chapter 176 of the Texas Local Government Code by the Texas legislature, new rules have expanded personnel who are subject to conflict of interest requirements. In summary the new CIS form requires that applicable staff file these forms if they have a conflict of interest, and if they are involved in the (a) planning, (b) recommending, (c) selecting, or (d) contracting of a vendor. Conflict of interest is defined as having: (1) an employment/business relationship, (2) receiving a gift of more than \$100 in the aggregate, or (3) or having a family relationship.
