As mentioned in last week's newsletter, members of the Schools division staff and I traveled to Chicago to visit five sites, all operated by Camelot-a provider of alternative education solutions. We departed Houston this past Sunday and returned Tuesday. Over the two-day period, we observed three of their campus environment types at five different locations. Their Transition program can be likened to our Highpoint schools while the Therapeutic Day School can be somewhat compared to our Academic and Behavior Schools, with the exception that their program is catered more to students who are strictly emotionally disturbed. As you know, our Academic and Behavior campuses cater to a much broader base of students on a wider spectrum of special needs. The Excel program helps overage students recover academic credits, which is extraordinarily helpful to students in that position. I found the visit to be very informative. Moving forward, the members of our Schools staff who attended the visit are eager to consider the principles of the most successful elements we observed for consideration as we work to better meet the needs of the students we serve. Upon my return to the office Wednesday, I attended the Houston East End Area Chamber of Commerce's 4th Annual Education Symposium. Last year, I participated in this event by serving as a panelist. This was an excellent networking opportunity and it served as an essential platform for HCDE to attend since we are located in the service area of this active organization in our immediate community. I am appreciative of the relationship that HCDE continues to maintain with this entity as well as with area school districts. To that end, on Wednesday, I also met with the superintendent of Fort Bend ISD as I continue to increase relations between the Department and area school districts.

We continued with budget meetings yesterday as we work to bring budget preparation and analysis to closure for next year's budget cycle. I will keep you apprised as we approach our presentation to you for Board approval.

Today, I attended the Upskill Houston Tri-Agency Workforce Initiative Houston Response Meeting–a Workforce, Education and Industry Forum. Governor Greg Abbott established this initiative to assess local economic activity, examine workforce challenges and opportunities, and consider innovative approaches to meet the state's workforce goals. I was asked to participate in today's roundtable discussion on behalf of the K-12 perspective, along with other Houston area superintendents and representatives from area charter schools as well as the Region 4 Education Service Center. This is a timely event given the focus of our Adult Education division as they bridge education and industry to help fortify Houston's workforce.

I will be attending the 2016 All-Earth Ecobot Challenge tomorrow at the Humble Civic Center. As you know, the EcoBot Challenge is an amazing event and we look forward to yet another successful this year.

Please be reminded that our rescheduled April Board Meeting will take place Monday, May 2. Also next week, I will be preparing for the American Leadership Forum kickoff retreat for its newest class of members. I look forward to this mind-opening experience.

CASE for Kids Showcases Educator Training Opportunities during Afterschool Professionals Appreciation Week



Comprehensive offerings in afterschool professional development are being showcased by the Center for Afterschool, Summer and Enrichment for Kids, or CASE for Kids. The online and live workshops are being promoted during Afterschool Professionals Appreciation Week, from April 25-29.

"We're committed to strengthening the skills of those working in the afterschool profession," said Lisa Thompson-Caruthers, director of CASE for Kids. "As an outgrowth of this commitment, we offer extensive professional opportunities throughout the year to support out-of-school time professionals."

CASE for Kids is an afterschool intermediary which provides funding, professional development, and networking for the local out-of-school time community. Funds support students in grades pre-k through 12 in afterschool programs in schools, child care facilities, and community centers. Services benefit approximately 12,000 kids in greater Harris County.

"Afterschool Professionals Appreciation Week, a first-time national awareness-raising event, gives us the opportunity to highlight the accomplishments of our local afterschool professionals," Thompson-Caruthers said.

Nationwide, an estimated 850,000 professionals work with the 10.2 million children who participate in afterschool programs each year. Afterschool offers an extension of the school day to enrich academics, broaden hobbies, and explore career possibilities. Training for afterschool professionals helps enhance the benefits of out-of-school time.

Topics for afterschool professional workshops, conferences, and symposiums range from science, technology, engineering and math, or STEM, to behavior management to CPR.

A free, online training platform called Cypherworx provides 36 courses and useful resources for afterschool professionals.

"Research shows that professional development facilitates staff performance, and knowledge is vital to the success of afterschool programs," said Thompson-Caruthers.

Through its annual End-of-Year Celebration on May 24, CASE for Kids will award its Professional Development Recognition Certificate to afterschool professionals who have completed multiple trainings throughout the 2015-2016 school year with CASE for Kids.
