CASE for Kids Makes Summer Learning Day "Out of this World"



Harris County Department of Education's Center for Afterschool, Summer and Enrichment for Kids, or CASE for Kids, celebrates what makes afterschool programs "out of this world" with Summer Learning Day on July 13.

Children ages 5-13 attending Harris County summer afterschool programs will participate in the event focused on science and numeracy from 9 a.m. to 1 p.m. at HCDE's North Post Oak Building, 6005 Westview.

Using the theme, "Afterschool is Out of This World," this event allows students to experience a variety of hands-on, engaging activities that promote learning, exploration, and skill development.

Activities include a portable planetarium from the Houston Museum of Natural Science, a rocket launch and a mock space escape room challenge. Students will also create a special intergalactic substance that they can take home.

Summer Learning Day is an annual national advocacy day led by the National Summer Learning Association (NSLA) to elevate the importance of keeping kids learning, safe, and healthy every summer.

CASE Workshop Cultivates Science Literacy in Problem-Based Approach to Farming



CASE for Kids held a science workshop for out-of-school time service staff to explore ways to introduce scientific concepts to their students.

Participants rotated through open-ended stations that dealt with physical concepts like air resistance, gravity, inertia, and pendula and allowed students to experiment on their own. Workshop leader Denise Johnson drew on examples from the farming industry as real-world applications. This problem-based approach to farming acted as the central motivation to communicate the scientific ideas to young learners.

After each station, Ms. Johnson led a group reflection, using language and explanations to encourage early scientific literacy. The stations allowed for modification for students with IEPs or other obstacles and ease of translation into afterschool programs, school-age child care centers, and summer camps.

Each year, a special panel of national jurors selects two students from each grade for this prestigious award. In


addition to being honored at the national ceremony, Deshpande and Martinez will receive \$500.

HCDE Releases Harris County School Districts Calendar 2017-2018 for 25 Area Districts



Harris County Department of Education's annual Harris County School Districts 2017-2018 Calendar is now available online. HCDE has produced the calendar for the past 15 years. It features the school year's start and end dates, spring and winter breaks, and student and staff holidays of all 25 Harris County districts that HCDE serves, as approved by the district boards.

State law mandates that schools begin no earlier than the fourth Monday of August, which lands on Aug. 28 this year. However, some Harris County districts have "district of innovation" status that allows them to waive this state regulation and opt for an earlier start date. A Texas school district must have an acceptable performance rating and create a comprehensive plan of innovation for a five-year term in order to become a district of innovation.

Students across all 25 districts have matching, weeklong Thanksgiving breaks November 20-24 and weeklong spring breaks March 12-16. All 25 districts are also closed on Friday, March 30 for Easter. Summer vacation starts up once again in 2018 between May 24 and June 1 for all Harris County districts.
