The conferences focused on seven tracks associated with operating a successful recovery high school program. The tracks were identified as follows: collegiate, high school, research, treatment, family, student, and diversity. The plethora of sessions surrounding these topics were facilitated by experts hailing from notable think tanks, universities, and medical institutions, and other related entities. All presenters were subject matter experts in their respective areas, and each area is essential in productive recovery environments.

My staff and I are committed to ensuring that the first public recovery school environment in Harris County provides an exceptional environment, grooming each student for academic successes.

#### CASE for Kids Provides Tips to Prevent "Summer Slide"



HCDE's Center for Afterschool, Summer and Enrichment for Kids, or CASE for Kids, offers tips to parents to prevent the "summer slide," or the loss of academic skills and knowledge over the summer.

According to the National Summer Learning Association, most youth lose approximately

two months of math skills and two to three months of reading during the summer. This loss is one of the most significant causes of the achievement gap between lower and higher income youth and one of the strongest contributors to the high school dropout rate.

CASE for Kids offers parents the following tips to keep kids learning during the summer and close the achievement gap:

- 1. Dust off the library card. Reading is the best and often cheapest way to keep kids' minds engaged during the summer.
- 2. Hit the "off" button. Screen time (phone, television, etc.) should be limited during the summer. Otherwise, kids may find little motivation to get much-needed exercise or participate in other summer learning activities.
- 3. Get creative. Kids love painting, drawing, and constructing when they're at school, so encourage them to do the same at home.
- Leave the house. Going to a park or riding a bike may not sound like "summer learning," but studies show healthy bodies and healthy minds are linked.
- 5. Don't forget two plus two. Keep kids' STEM brains in gear by doing small things like measuring flour and sugar for baking, calculating the grocery bill, or using flash cards or free online worksheets.

HCDE's Center for Safe and Secure Schools staff recently attended the 2017 Texas School-Based Law Enforcement Conference and presented on Restorative Discipline Practices

at the annual Summer Leadership Institute (SLI).

The School-Based Law Enforcement Conference held in Corpus Christi, Texas was customized to equip school-based law enforcement officers and administrators with evidencebased practices, resources and information on current trends in violence prevention, emergency management strategies and various campus safety issues. During the SLI, a flagship training conference for the Texas Association of School Boards, the Center for Safe and Secure Schools staff presented on Restorative Discipline Practices and how they can proactively reduce violence and the use of exclusionary practices



such as in-school and out-of-school suspensions.

#### ECPA Staff Engaged in Multiple Summer Teacher Training Sessions



Fifteen aspiring teachers successfully completed the Educator Certification and Professional Advancement Summer Curriculum and Instruction Institute this summer. The nine-week course combined evening,

Saturday and online courses for teachers participating in pre-service to prepare for the upcoming school year. Topics covered include ethics and professional responsibilities, organization and management, standards and alignment, lesson plan, content methods, working with diverse populations, analyzing date and assessment, and field observations.

Last month ECPA early career teachers completed a fiveday facilitator institute led by manager Jonett Edwards Miniel. The teachers practiced community building skills and learned how to use protocols to examine texts, student work, classroom dilemmas and data.

Research from over 3,000 students enrolled in afterschool in the Houston area through the Texas Education Agency's Afterschool Centers on Education (ACE) program was uploaded by Research and Evaluation Institute staff on behalf of CASE for Kids.
