CASE for Kids to Attend Out-of-School Time Initiatives Conference

Members of the CASE for Kids staff will attend the Out-of-School-Time Initiatives Conference, or OSTI-CON, June 23-25 in Dallas. The annual event gathers the nations' leading out-of-school-time and expanded learning professionals for workshop sessions designed to be applicable to any youth program and for any state. As the conference is generously underwritten by the Texas Education Agency, some strands are designated for the Texas ACE Program.

CASE for Kids' Family Engagement Specialist Claudia Magallan will present a workshop entitled *Zoom in on Engagement: Meeting the Need of Individual Families* at the conference. Her workshop will teach participants how to zoom into the needs of families, schools, and the community to implement empowering programming and long-term engagement.

CASE for Kids Partners to Host College Tours for Texas ACE-21st Century Sites

CASE for Kids partnered with the Educational Opportunity Centers Program at Texas Southern University to render college informative workshops with the purpose of expanding services and creating a college-bound culture. The tour was designed to target students enrolled in CASE for Kids Texas ACE-21st Century programs that will be first or second generation college students, along with their parents, to participate in college tours for the 2015 summer. Yes Prep West, Sharpstown International and Galena Park HS are the respective campuses participating in the tours. This opportunity will allow students to have real insight and receive a firsthand view of Houston's local universities.

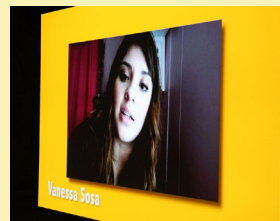

Some of the best teen writers and artists from Harris County traveled to New York City's Carnegie Hall in June to be honored with Scholastic Art & Writing Silver and Gold Medals. In all, 39 Harris County teen writers and artists earned recognition as national Scholastic Art & Writing medalists. Nine made their way to New York City with four teachers to earn

their awards. The Awards are sponsored regionally by Harris County Department of Education.

"What the Awards do is to give students that boost in confidence in their abilities in art and writing and ultimately their futures," said Kent. "What our teens say is that they see limitless possibilities for their futures after being recognized in New York City."

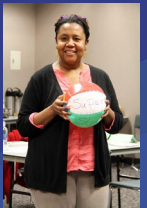
