Of Note...

This week was a busy one for me as I traveled to Austin last weekend to attend the UT/TASSB Summer Conference which concluded this past Tuesday. The conference was both informative and enlightening with powerful keynote speakers such as recently retired four-star admiral and former Navy SEAL Bill McRaven, who is currently the UT Chancellor. (You will recall that he led the special operations forces that seized Osama bin Laden during the raid in Afghanistan in May 2011.) The series of sessions this week served as a great opportunity for superintendents to further develop leadership abilities without the concern of being away from district offices during the regular academic session. It was also an ideal time to network with my distinguished colleagues from school districts across the state of Texas.

I returned to the office on Wednesday, and I am happy to inform you that even during the summer months, HCDE continues to serve as a beacon of light in the teaching and learning sphere. This week, our professional development staff hosted four trainings in preparation for the 2015-16 academic year. This week's training topics and areas of interest included problem-solving in operations and algebraic reasoning (mathematics); web-based instructors' training (digital learning); launching a campus or school district project-based learning initiative (project-based learning); and teaching methods for diverse learners (diversity in teaching and learning). Our staff is not only committed to excellence within HCDE, but also excellence across Harris County as they impart their unique expertise on the educators in our client districts.

I would also like to direct your attention to page 2 of this issue of **The Connector**. I am pleased to report that 25 Harris County area schools are sharing in \$650,000 of afterschool funding for the 2015-2016 school year. Schools included in this distribution of funds are in Aldine, Alief, Galena Park, Houston, Pasadena, and Sheldon independent school districts. A Houston area charter school was also awarded. This is an exciting time for our CASE division, and we are proud to be able to distribute resources that will advance quality afterschool programming in 24 schools in six (6) Harris County area school districts, as well as to a Houston based charter school.

I am equally excited that our Teacher Alternative Certification program is preparing 30 new teachers for the classroom for the 2015-2016 school year-through an intensive program of 90 hours of training over a six-week period this summer. Upon successful completion of training, observations, and passing of subject-area state mandated tests, they will be placed in full-time teaching positions. Great things are happening at HCDE.

As I work to catch up from my absence earlier this week due to professional development, please be reminded that the July Board Meeting will be held on Tuesday, July 21, 2015 at 1:00 p.m. Also, please remember to save the date for the HCDE Annual Staff Meeting that will be held on Wednesday, August 19, 2015 at the Humble Civic Center at 11:30 a.m.

PROGRAM CONNECTIONS

25 Harris County Schools to Share \$650,000 in Afterschool Funding in 2015-2016

Twenty-five schools in Aldine, Alief, Galena Park, Houston, Pasadena, and Sheldon, and a Houston-based state charter school will receive a share of \$650,000 in afterschool funding as the 2015-2016 school year begins. The program called the Partnership Project is administered by the Center for After-School, Summer and Expanded Learning for Kids, or CASE for Kids, a division of Harris County Department of Education. Funding is designated for economically disadvantaged children ages 4-12, and is provided by the Houston-Galveston Area Council, the Texas Workforce Commission, and local foundations.

Harris County Department of Education commits local funds to supplement literacy and numeracy activities in quality, out-of-school time programming for youth. Those funds are matched with a commitment of federal childcare funds for quality improvement for school-age youth through the Texas Workforce Commission. HCDE provides a variety of resources such as training, site visits, scholarships, and a lending library to the 25 selected sites.

"The goal of the Partnership Project is to invest in comprehensive afterschool programs that have a primary focus on numeracy and literacy development," said CASE for Kids Director Lisa Thompson-Caruthers. "CASE will provide funded project support for numeracy and literacy integration into academic and enrichment activities, as well as site-based coaching to improve overall program quality."

TEKS Workshop Brings Together 80 Area Math Teachers for Math Strategies



Summer Curriculum Institute Gets 30 New Teachers Prepared for Classrooms this Fall



Teacher Alternative Certification hosted the Summer Curriculum Institute this past six weeks to provide training for 30 aspiring teachers. The intensive program provides 90 hours of training over a six-week period for degreed candidates in the pre-service phase of teaching. After potential teachers take the courses, observe in classrooms and pass the subject-area state mandated tests, they are placed in teaching positions in districts. Guidance for teachers is provided by HCDE for an additional two years.
