IN THIS ISSUE OF NOTE



It was a great week at HCDE! As you are already aware, the State Auditor's Office released its report on the Selected State Contracts and Grants audit it conducted at HCDE over the past several months. The State Auditor concluded that HCDE had controls in place to ensure that funds from state contracts and grants were used for the intended purposes. It also found that HCDE complied with laws, policies, procedures, and other measures when tracking and spending those funds. In addition, the report stated that HCDE spent property tax revenue it collected in accordance with state laws and, to that end, those funds were used to provide school-based therapy services and education services for students who are at-risk and for those with emotional and special academic needs. The labor-intensive audit was conducted by a team of Certified Public Accountants and auditors who are regularly tasked to review various state agencies to find operational inefficiencies, spending or control irregularities, as well as wasteful, or even fraudulent spending. That said, since the State Auditor's Office is the independent auditor for Texas state government, we're both pleased and proud to share the positive findings of this report. Likewise, systems have been put in place to address the recommendations contained in the report.

Meanwhile, I spent much of the week in Dallas and Austin. I took advantage of the opportunity to spend guality time with Superintendent Rick Sorrells at Dallas County Department of Education where we toured several facilities under the auspices of our Dallas counterpart. In addition to that meeting and site visits, I attended the Dallas ISD State of the Schools address, sponsored by the Dallas area Chamber of Commerce, where Interim Superintendent Michael Hinojosa was the keynote speaker. I visited, probably one of the most unique schools in the Dallas metroplex, Conrad High School. This international school in Dallas ISD serves 2,000 students with 47 different languages spoken. It was an impressive campus operation.

My Dallas area meetings concluded after I connected with Mr. Gordon Taylor, Executive Director of Region 10. We had an opportunity to discuss HCDE's role in education, including our commonalities and partnerships. I am pleased with having made these significant contacts in that area of the state. Most importantly, all of the meetings were forward-moving and provoked the sharing of ideas as we each discussed innovative methods to advance our respective missions and goals.

Yesterday, I attended the continuance of the UIL hearings related to the San Antonio/referee incident that occurred over the Labor Day holiday weekend. Again, my participation in this process is to fulfill my duties and responsibilities in my official capacity as a member of the State Executive Committee of the UIL. As mentioned before, my role on this Executive Committee continues to allow me to increase HCDE's visibility on the state and national stages.

You may have heard or read in local news this week that the Texas Education Agency Commissioner issued notice to La Marque ISD officials that their Board and Superintendent will, indeed, be replaced. After thorough review of the district's overall operations, TEA Commissioner Michael Williams determined that ultimate oversight of the district would go in a different direction. For example, their Board of Trustees will be replaced by an appointed Board of Managers. Unfortunately, the district's areas of need exceeded the areas of business and finance, where HCDE assisted LMISD with great fiscal management improvements. In fact, HCDE was recently recognized by the Houston Chronicle for the expertise it provided the district. We will work with both the district and the Commissioner, as necessary, during this transition period. It should be noted, however, that HCDE's business team made great strides on behalf of La Marque ISD over the past several months.

We ended the week on a high note, through service to the community with the CASE for Kids 2015 Out-of-School Time Conference, which goes through tomorrow at the Memorial City location of the Westin Hotel. What a week of success in furthering our mission to create value, deliver opportunity, and provide service!

In closing, I hope you were able to tune in to KHOU/Channel 11 last Friday to see the interview that featured several HCDE employees as they discussed special education. On page 3 of this issue of **The Connector**, there is a link to the story on the KHOU website. It highlighted HCDE as a unique education resource in Harris County. Next, the 100 Rooms of the Administration Building served as the venue for a neighborhood Mayoral Candidates' Forum last night. We served as a center for this important community event for our area constituents which allowed citizens and candidates, alike, to be heard.

Service Connections

HCDE Receives Good Report Card from State Auditor's Office

Harris County Department of Education received a good report card from the State Auditor's Office through findings of a comprehensive audit conducted between January and June of this year.

The audit released on September 23 analyzed HCDE's work for fiscal years 2012, 2013, and 2014. The report supports HCDE's goal of fiscal accountability, stating that HCDE spent property tax revenue it collected in accordance with applicable state laws. It also found that HCDE "had controls in place to help ensure that it received and used funds from state grants and contracts for the intended purposes." Auditors said that HCDE complied with applicable terms and conditions, policies and procedures, state laws, and administrative rules.
