### HCDE Board Approves Tax Rate Lower than Effective Tax Rate for 2018

This week, the Board adopted a lower tax rate in a move to conserve tax dollars. For the fourth consecutive year, the Board voted to approve a proposed rate of \$.005190 for HCDE, significantly lower than the effective tax rate for 2018 of \$0.005279, and also lower than last year's HCDE tax rate of \$.005195.

#### HCDE Board Adopts Lower Tax Rate in Move to Conserve Tax Dollars

Sept. 20, 2018 - In a move to continue its fiscal accountability, Harris County Department of Education's Board of Trustees voted for a fourth consecutive year to adopt a tax rate below the effective tax rate.

HCDE trustees adopted the proposed rate of \$.005190 in a vote of six to one. The rate is significantly lower than the 2018 effective tax rate of \$0.005279 and lower than last year's (2017) tax rate of \$.005195.

"We continue to be below the effective tax rate," said HCDE Board President Louis D. Evans III. "We are going to go back and take a look at everything to make sure there is no waste. We will make sure that we can still provide our current services, expand the number of students that need to be served, and still represent the taxpayers."

With an average Harris County residence valued at \$169,843 in August 2018, the adopted rate of \$.005190 per \$100 assessed property value will mean the average homeowner will pay \$8.81, less than \$9 a year for HCDE services.

Services from HCDE benefit school districts and the community at large and include adult education, special schools, school-based therapy services and afterschool programming.

**About Harris County Department of Education:** HCDE provides special education, therapy services, early education, adult education and after-school programming. Services are funded by government grants, fees and a local property tax of less than \$9 per homeowner. For every dollar in local property tax collected, HCDE provides \$4.70 in services to the 25 Harris County school districts. We operate four campuses for students with profound special education needs and adjudicated or recovering youth who require a low, student-teacher ratio and highly structured environment. One-hundred percent of students served on HCDE campuses are at-risk. We are governed by an elected board of seven trustees and have 1,076 employees and 33 facilities, including 15 Head Start centers. ### HCDE Head Start Recruits Students for Immediate Openings in 4 Communities



Four Harris County Department of Education Head Start centers (Baytown, Humble, La Porte and Tidwell) are recruiting students ages 3-5 for preschool for the 2018-19 school year. In addition, Early Head Start services to children 6 weeks to 3 years of age are available at the Baytown Head Start Center.

Head Start ensures future success for students both academically and socially and provides comprehensive health, education, nutrition and financial services to the families. Healthy meals and snacks are provided for students during the day.

Parent involvement opportunities are provided along with service referrals to meet family needs. Family engagement activities are hallmark to the program.

Eligible children are those from low-income families and with disabilities between ages 3-5.

Applicants should present the following at registration:

- Proof of age- child's state birth certificate, state birth facts or passport
- Proof of address- lease contract, current utility bill, state ID, benefits letter or paycheck stub
- Proof of income- current tax form (W-2 or 1040), 12 months of check stubs, child support payment record, verification of Temporary Assistance for Needy Families or Supplemental Security Income

The centers are located at 1725 N. Pruett St. in Baytown, 130 Atascocita Rd. in Humble, 927 South 1st St. in La Porte and 8302 John Ralston Rd. in Houston (Tidwell). The Baytown Early Head Start center is located at 1319 N. Pruett St.



### Afterschool Vendors Showcase Services at CASE for Kids Providers Fair



About 100 afterschool programs from around the Houston area attended the

Sept. 18 annual Center for Afterschool, Summer and Enrichment, or CASE for Kids, Providers Fair to explore additional services to offer their students.



Fifty-five providers networked with schools ranging from fencing, art, STEM and character education.

The Healing Species came out to the fair to let schools know how they use rescue dogs to build a bridge between students and their hearts. They follow an 11-week violence

intervention/ character and compassion education outreach.

Students hear the rescue dog's story then they get to read a book that corresponds to the dog.

“These are used to teach motion and flow for children of all ages,” she said.

### Shift Your School Culture: Results of Study Revealed at Free Event at HCDE Oct. 23



Education researchers share lessons learned from a case study using Restorative Practices at a free

panel discussion on Oct. 23 from 9 a.m. to noon at Harris County Department of Education, 6300 Irvington Blvd. Chauncy Glover, three-time Emmy award-winning news anchor and reporter from KTRK-Channel 13 is the moderator for “Restoring School Culture.”

Harris County Department of Education’s Research and Evaluation Institute staff provide findings from the one-year, ongoing study about a Spring Independent School District, Title 1 middle school which uses Restorative Practices. Restorative Practices is an emerging, social science practice and philosophy that improves and repairs relationships within the school community.

Principal La’Quesha Grigsby from Spring ISD is a panelist and will share her insights. Additional panelists

include Jim Christensen, 33-year visionary educator and superintendent, who led the charge on implementing cultural change in his district. Charles Rotramel, CEO of nonprofit Houston reVison will discuss what it takes to work with students who are often labeled “the toughest kids.” Julia Andrews, school culture and climate specialist for HCDE’s Center for Safe and Secure Schools, provides insight on the implementation and training.

“We are inspired by the results of this study,” said Darlene Breaux, director for the Research and Evaluation Institute. “We are ready to share this with area educators so that they can begin to initiate the type of positive change that truly impacts school culture.”

I have been fully-engaged throughout the process with the Assistant Superintendent of Business, as well as with Executive Leadership Team members, and other personnel at varying levels within the Department, regarding this budget cycle.

While the budget had already been passed, this week, the Board adopted a lower tax rate in a move to conserve tax dollars. For the fourth consecutive year, the Board voted to approve a proposed rate of \$.005190, significantly lower than the effective tax rate for 2018 of \$0.005279, and also lower than last year's HCDE tax rate of \$.005195.

Having arrived at this week's critical point is the result of having executed and managed a planning process that resulted in goals, targets, and/or priorities for major operations.
